Points to note

- 1. At least 20 participants are required for each session.
- 2. Application should be made at least 4 weeks prior to the proposed date of health seminar.
- 3. Successful application will be notified by confirmation letter via fax or email in around 10 working days upon receipt of application. If school does not receive any confirmation, please contact our staff at 2185 6388.
- 4. Each session lasts for around 45 minutes. Prior notice should be given for special arrangement if allocated time is less than 45 minutes.
- 5. School should provide venues, computers and other equipment required for the health seminar. Prior notice should be given for special arrangement if computer equipment cannot be provided.
- 6. An information sheet on the alternative smoking products will be provided for the use on the seminar day. Materials will be delivered to school around 1 week prior to the seminar.
- 7. In case the health seminar has to be cancelled or postponed, please re-submit the form at least 5 working days prior to the previously confirmed health seminar session for further arrangement.
- 8. Hong Kong Council on Smoking and Health ("COSH") reserves the rights for final decision of the application for health seminar.
